## **Special Religious Education Participation Letter**

Dear Parent/Caregiver

A feature of the public education system in NSW is the opportunity to provide time in class for education in ethics, faith and morality from a religious or non-religious perspective at the choice of parents.

At Asquith Girls High School, students in Years 7-10 have the opportunity to participate in timetabled Special Religious Education (SRE) classes once a fortnight. The following SRE options are available:

- Combined Christian SRE is provided by the Hornsby and Asquith Districts Christian Education Association (HADCEA). If you do not wish for your child to attend SRE, they will be placed in a Non-SRE class (NSRE). Students in a Non-SRE class will complete independent study under the supervision of a teacher. It is important that students attend their timetabled class as per school attendance policy.
